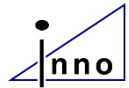
- Creating structures at cluster level through which peers can work together, connected across Europe

Pilot 3 : Cluster Collaboration



- Webinar 1: general introduction on the participants (7), presentation of the potential lines of collaboration. Discussion on the different clusters, and needs. Clear need of a very focused field of collaboration
- Webinar 2 : There was an initial discussion (among all webinar participants) on how could cross-cluster collaborations, across different sectors, and focused on KET application domain areas could be established. Some point that came out of this discussion are presented below:
 - There should be some concern on the type of actions to be proposed. Companies do not have the time to participate in workshops or other similar events if they don't see a real Return on investment.
 - There is a need to be very concrete on the type of work/actions this Pilot should take forward
 - Cross sectorial cluster collaboration is hard unless its opportunity driven.
 - There should be “ownership” of the activities to be developed and who induces the activities.
 - The matter of clusters being connected and collaborating with clusters of other sectorial areas seem to be rather new.
 - Cross cluster and cross sectorial Collaboration are key to further development, and issues such as internationalization can become the opportunity to join forces.
